Sharing by Secretary for Food and Health

The Chairman welcomed Prof Sophia CHAN, Secretary for Food and Health (SFH), for joining the Administrative & Operational Meeting (AOM). Prof Chan would complete her five-year tenure as SFH on 30 June 2022 under the current term of the Government.

- 2. <u>Prof Sophia CHAN</u> expressed deep appreciation to the Hospital Authority (HA) and its staff for their professionalism and dedication in helping Hong Kong people stay healthy over the years. In particular, the contributions and concerted efforts of the Head Office and Clusters in coping with the challenges in the unprecedented COVID-19 epidemic since 2020 were remarkable. She also thanked the Chairman and HA Chief Executive (CE) in leading HA to swiftly respond to the emergency situation and embark on various novel measures in the epidemic fight, such as the designated hospitals and the treatment centre at Asia World-Expo (AWE) for COVID-19 cases.
- 3. Prof Sophia CHAN emphasised that the Government was in full support of HA. In terms of resources, the Government had significantly increased its recurrent subvention to HA by over 60% in the past five years from 2017-18 to 2022-23. It enabled HA in developing services, and also provided additional support for HA to implement various staff recruitment and retention measures to address the persistent problem of healthcare manpower shortage, such as introduction of Specialty Nurse Allowance, recruitment of non-locally trained doctors (NLTDs), extension of employment beyond the retirement age, etc. She also showed appreciation to HA for its close collaboration with strategic partners and stakeholders in strengthening various healthcare initiatives, such as the development of genomic medicine, cancer strategy and Chinese Medicine, as well as prevention of chronic diseases, promotion of smoking cessation, etc. The team efforts of Hong Kong Children's Hospital in advising the public on the harmful effects of second hand smoke on children were all well appreciated.
- 4. <u>Prof Sophia CHAN</u> commended the HA Board's Task Group on Sustainability in taking forward strategic initiatives to address the imbalance in demand and supply of healthcare services in the face of Hong Kong's ageing population and rising prevalence of chronic diseases. Looking ahead, further development of primary healthcare could help alleviate the demand pressure for secondary and tertiary care in public hospitals, and she trusted HA would continue to support the Health Bureau under the new term of the Government to take forward the related initiatives
- 5. On behalf of the HA Board and the management, the Chairman expressed sincere gratitude to Prof Chan for her full support

to HA, particularly in resources and implementation of various sustainability initiatives amidst the unprecedented COVID-19 epidemic. Prof Chan's leadership and inspirations and her contributions to the formulation of the Primary Healthcare Blueprint under the current term of the Government had laid the foundation for reinforcing the development of primary healthcare for Hong Kong in the years ahead. The Chairman wished Prof Chan good health, happiness and success in all future endeavours.
