Declaration of Interest

Welcome Remarks

2. <u>The Chairman</u> welcomed the five sit-in colleagues, who were attachees from the Nursing, Allied Health and Administrative disciplines under the Corporate Exposure Programme of Hospital Authority (HA) Head Office.

Confirmation of Minutes

3. The draft minutes of the last Administrative and Operational Meeting (AOM) held on 22 September 2022 were confirmed without amendment.

Matters Arising

Circulation of Paper

4. It was reported that AOM Paper No. 1795 on "Enhancement to Home Loan Interest Subsidy Scheme - Proposed Amendments to the Terms and Conditions" was approved by the Board on 19 October 2022 via circulation.

Update on Appointment of Cluster Chief Executive (New Territories West) and Hospital Chief Executive (Tuen Mun Hospital)

(<u>Members</u> noted that following the approval of the Board, the appointment of Dr WONG Yiu-chung (王耀忠醫生) as Cluster Chief Executive (New Territories West) and Hospital Chief Executive (Tuen Mun Hospital) would take effect from 1 November 2022. The details were separately recorded in paragraphs 5 to 6.)

Exploration of Information Technology Collaborations and Service Provision in Guangdong-Hong Kong-Macao Greater Bay Area (Confidential AOM Paper No.1796)

(Members deliberated on the proposed strategic direction for HA to support the exploration of information technology collaborations in Hong Kong and other regions in the Guangdong-Hong Kong-Macao Greater Bay Area (GBA), and the provision of some technology services and solutions, as well as the proposed way forward. 26. <u>Members</u> approved the proposed appointments / reappointments to the Functional Committees and the Central Training and Development Committee of the HA Board as detailed in the paper, which were endorsed by the Executive Committee (EC) at its meeting held on 7 October 2022.

Amendment to Trust Deed of The Princess Margaret Hospital Charitable Trust

(Restricted AOM Paper No.1798)

27. <u>Members</u> approved the amendment to the trust deed of The Princess Margaret Hospital Charitable Trust, as detailed in the <u>Annex</u> to the paper, in response to the advice of the Inland Revenue Department. The Board also authorised the Chairman, Chief Executive and any one member of the Board to fix the seal of HA and authenticate the fixing of the seal for executing the trust deed for effecting the amendments.

Collaboration with Hong Kong Science and Technology Parks Corporation on Use of Health Data for Research and Development (Restricted AOM Paper No.1799)

(This subject was discussed and <u>Members</u> noted the collaboration between HA and Hong Kong Science and Technology Parks Corporation on the use of health data for research and development. The detailed deliberations were separately recorded in paragraphs 28 to 33.)

Annual Report on Hospital Authority Mandatory Provident Fund Scheme

(Confidential AOM Paper No.1800)

(<u>Members</u> noted the Annual Report of the Hospital Authority Mandatory Provident Fund Scheme (HAMPFS) as at 31 March 2022 and the way forward for strengthening governance and support of HAMPFS. The details were separately recorded in paragraphs 34 to 36.)

Hospital Authority Provident Fund Scheme Annual Operation Report 2021/22

(Restricted AOM Paper No.1801)

(<u>Members</u> noted the 2021/22 Annual Operation Report of the HA Provident Fund Scheme. The details were separately recorded in paragraphs 37 to 39.)

Annual Update on Electronic Health Record Programme Undertaken by the Hospital Authority (Restricted AOM Paper No.1802)

(This subject was discussed and <u>Members</u> noted the annual update on the progress of the Electronic Health Record (eHR) Programme undertaken by HA as the Government's technical agency, as well as the implementation progress in respect of HA as a major user of the eHR Sharing System. The detailed deliberations were separately recorded in paragraphs 40 to 44.)

2021/22 Annual Service Report on Chinese Medicine Clinics cum Training and Research Centres and Integrated Chinese-Western Medicine Programme

(Restricted AOM Paper No.1803)

(<u>Members</u> noted the annual service report on the Chinese Medicine (CM) Clinics Cum Training and Research Centres and Integrated Chinese-Western Medicine (ICWM) Programme for 2021/22. The details were separately recorded in paragraphs 45 to 46.)

Updates on COVID-19

(<u>Members</u> noted the updates on COVID-19 in respect of the latest situation; bed mobilisation; latest visiting arrangement in HA hospitals; and HA's strategies for COVID-19 and seasonal influenza surge. The detailed deliberations were separately recorded in paragraph 47.)

The Chief Executive's 2022 Policy Address (AOM Paper No.1804)

48. Mr Andy LAU highlighted the key aspects from relevant extracts of the Chief Executive's 2022 Policy Address, Policy Measures, and Indicators for Specified Tasks announced on 19 October 2022, covering public hospital services, primary healthcare and CM development, healthcare manpower, health technology, etc. On HA, directions were laid down in the Policy Address to enhance healthcare services, specifically to reduce waiting time at Specialist Out-patient

Clinics, improve patient experience including wider use of telehealth services and drug collection, increase CM out-patient service quotas, regularise services of ICWM, set up a Poison Control Centre, expand HA's Discharge Support Programme, Integrated strengthen infrastructure, promote eHealth, etc. Accreditation-related work would also be resumed in at least two public hospitals. On collaboration, HA would continue to explore with Hong Kong Science and Technology Parks Corporation on the use of the HA's clinical data for R&D, deepen CM collaboration in the GBA, strengthen support for patients with uncommon disorders in collaboration with the Hong Kong Genome Institute, etc. More details of the measures and indicators were set out in the Policy Address, with relevant extracts reproduced on the paper.

49. The Chairman remarked that many of the healthcare-related Policy Measures were set out by the Government in liaison with HA. The implementation progress of the Government's measures would be subject to public accountability. While HA was confident in meeting the set deliverables, there could be unforeseeable events or situations impacting on the planned progress. For example, the target to reduce the waiting time of stable new case bookings for the specialty of Medicine by 20% in 2023-24 could be affected by unexpected surge in service demand or an outbreak of disease requiring additional resources for emergency responses. In this regard, a mechanism had to be set up to monitor the progress regularly with prompt actions to be taken to address potential issues arising from unexpected events. To this end, quarterly reports to EC and biannual reports to the Board at AOM would facilitate regular monitoring of the performance against the Indicators for Specified Tasks relevant to HA. The Secretariat would coordinate with subject officers on the said reporting.
