Service Sustainability in Ophthalmology - Rising Demand for Elective Cataract Operations in the Hospital Authority (Confidential AOM Paper No.1881)

(This subject was discussed and <u>Members</u> noted the rising service demand in elective cataract operations, the pressure faced by Ophthalmology services in HA and the existing measures in managing the waiting time of elective cataract operations, and approved the proposed new strategies, including the Team-based Piece Rate Remuneration Scheme, for enhancing the sustainability of Ophthalmology services in HA.
