Declaration of Interest

<u>The Chairman</u> invited Members to declare conflict of interest, if any, arising from the agenda items of, or discussion at, the meeting. There was no declaration from Members.

Welcome Remarks

2. <u>The Chairman</u> welcomed the six sit-in colleagues, who were attachees from the Allied Health, Nursing and the Administrative disciplines under the Corporate Exposure Programme of the Hospital Authority (HA) Head Office (HO).

Confirmation of Minutes

3. The draft minutes of the last Administrative & Operational Meeting (AOM) held on 21 September 2023 were confirmed without amendment.

Matters Arising

Expansion of Special Honorarium Scheme (Special Duties) for Weekday Elective Operating Theatre Sessions in Hospitals with Severe Manpower Deficiency (Restricted AOM Paper No.1901)

(The subject was discussed and <u>Members</u> approved the proposed expansion of the Special Honorarium Scheme (SHS) (Special Duties) to include weekday elective Operating Theatre sessions in hospitals facing a severe shortage of Anaesthesiologists. The detailed deliberations were separately recorded in paragraphs 4 to 7.)

Proposed Employment Package for Full-time Visiting Doctors from Macao for Specialist Training (Confidential AOM Paper No.1890)

(The subject was discussed and <u>Members</u> approved the proposed employment package for full-time visiting doctors from Macao for completion of their specialist training in hospitals of HA. The detailed deliberations were separately recorded in paragraphs 8 to 14.)

Review on Training Undertakings (Confidential AOM Paper No.1891)

(The subject was discussed and <u>Members</u> approved the proposed revision of the undertaking arrangements for training outside Hong Kong as one of the staff retention strategies, subject to further external legal advice to

be obtained. The detailed deliberations were separately recorded in paragraphs 15 to 21.)

(Dr Tony KO left at this juncture, and Dr W K CHING represented the Chief Executive to attend the meeting.)

Proposed Enhancement Measures to Attract and Retain Supporting Staff

(Confidential AOM Paper No.1892)

(The subject was discussed and <u>Members</u> noted the manpower situation of supporting staff and the staff retention measures planned for implementation by HA; approved the proposals on merging of IIIA and IIIB levels and changes in entry pay for Patient Care Assistant / Operation Assistant / Executive Assistant to attract and retain supporting staff; and supported the extended scope of SHS to cover non-clinical projects. The detailed deliberations were separately recorded in paragraphs 22 to 25.)

Annual Report on Hospital Authority Mandatory Provident Fund Scheme and Proposal on Way Forward (Confidential AOM Paper No.1893)

(The subject was discussed and <u>Members</u> noted the Annual Report of the Hospital Authority Mandatory Provident Fund Scheme (HAMPFS) as at 31 March 2023; the way forward for engaging additional service provider(s) for HAMPFS; and the change in sponsorship for Invesco Strategic Mandatory Provident Fund Scheme, and suggested further reviewing the appropriate number of service providers required by HA. The detailed deliberations were separately recorded in paragraphs 26 to 35.)

(<u>Members</u> noted the HA Provident Fund Scheme Annual Operation Report 2022/23. The detailed deliberations were separately recorded in paragraphs 36 to 37.)

Annual Update on Electronic Health Record Programme Undertaken by the Hospital Authority (Restricted AOM Paper No.1895)

(The subject was discussed and <u>Members</u> noted the annual update on the progress of the Electronic Health Record (eHR) Programme undertaken by HA as the Government's technical agency and the implementation progress in respect of HA as a healthcare provider participating in eHR

Sharing System. The detailed deliberations were separately recorded in paragraphs 38 to 45.)

2022/23 Annual Service Report on Chinese Medicine Clinics cum Training and Research Centres and Integrated Chinese-Western Medicine Programme

(Restricted AOM Paper No.1896)

(<u>Members</u> noted the annual service report of the on Chinese Medicine Clinics cum Training and Research Centres and Integrated Chinese-Western Medicine Programme for 2022/23. The detailed deliberations were separately recorded in paragraphs 46 to 48.)

Corporate Communication Work Plan (Restricted AOM Paper No.1897)

(The subject was discussed and <u>Members</u> noted the corporate communication plan of HA for 2023/24. The detailed deliberations were separately recorded in paragraphs 49 to 55.)

Hospital Authority's Action Items under The Chief Executive's 2022 Policy Address

(Restricted AOM Paper No.1898)

(without presentation)

Members noted the second bi-annual report on the implementation of the action items to take forward specific healthcare-related items relevant to HA as set out in the Hong Kong Special Administrative Region Chief Executive (HKSAR CE)'s 2022 Policy Address (2022 PA). Some of the action items had been completed and others continued to be in good progress.

The Chief Executive's 2023 Policy Address (AOM Paper No.1899)

- Mr Andy LAU highlighted the key aspects from relevant extracts of the HKSAR CE's 2023 Policy Address (2023 PA), Policy Measures, and Indicators for Specified Tasks announced on 25 October 2023, covering public hospital services, primary healthcare and Chinese Medicine (CM) development, healthcare manpower, health technology, etc.
- 58. On HA, directions were laid down in the Policy Address to enhance healthcare services, specifically to shorten the waiting time of stable new cases of two specialties, namely Ear, Nose and Throat, and Orthopaedics and Traumatology; promote ICWM programmes; optimise the ratio of case manager to patients with severe mental illness under the

Case Management Programme; establish Hong Kong's first Chest Pain Centre in Queen Marry Hospital in 2025 in accordance with national accreditation standards; set up a breastmilk bank; increase public service quota for assisted reproductive services; establish "Cluster Clinical Research Support Office" to promote clinical research and trials in public healthcare system; keep attracting more healthcare talents and strengthening exchange and co-operation through different programmes; resume the hospital accreditation programme and adopt the "International Hospital Quality Accreditation Standards (China)" to ensure that public hospitals were up to international hospital quality standards. More details of the measures and indicators were set out in the Policy Address, with relevant extracts reproduced on the paper.

- 59. Action plan was being formulated to implement the initiatives for the benefit of patients. In accordance with the prevailing mechanism for the progress reporting on HA action items for 2022 PA, progress on the implementation of HA's actions items for 2023 PA would be reported to the Executive Committee (EC) on quarterly basis and to the HA Board bi-annually to facilitate monitoring and follow up.
- 60. Without particular comment, <u>Members</u> noted the relevant contents of the HKSAR CE's 2023 PA and Policy Measures that were related to HA, public hospital services, primary healthcare and CM development, healthcare manpower, health technology, etc., and the monitoring of various indicators for specified tasks related to HA.
