# 2024/25 Annual Pay Adjustment of the Hospital Authority (Confidential AOM Paper No.1965)

(without presentation)

6. <u>Members</u> approved the proposal to adopt and apply the 2024/25 Civil Service Annual Pay Adjustment (APA) rates, i.e. pay increase at 3%, to all eligible employees of HA with retrospective effect from 1 April 2024, the revised HA pay scales and pay ranges, and the proposed mechanism for consideration of special cases for APA back pay. Details were set out in the paper and the presentation slides distributed to Members.

Members approved the re-appointment of seven co-opted members of the Guangdong-Hong Kong-Macao Greater Bay Area Advisory Committee, including Dr the Hon Eliza CHAN Ching-har, GBS, JP (陳清霞女士), Dr the Hon KO Wing-man, GBS, JP (高永文醫生), Mrs Ann KUNG YEUNG Yun-chi, BBS, JP (龔楊恩慈女士), Dr the Hon David LAM Tzit-Yuen (林哲玄醫生); Mr Antony LEUNG Kam-chung, GBS, JP (梁 錦 松 先 生); Dr PANG Yiu-kai, GBS, JP (彭耀佳先生); and Prof Anthony WU Ting-yuk, GBS, JP (胡定旭教授) upon expiry of their current term for a term of two years from 1 September 2024 to 31 August 2026.

- 8. <u>Members</u> approved :
  - (a) the appointment of Mrs Ann KUNG YEUNG Yun-chi, BBS, JP (龔楊恩慈女士), currently Chairlady of the Hospital Governing Committee (HGC) of Hong Kong Children's Hospital (HKCH), vice the retirement of Mr John LEE Luen-wai, as the Chairman of the Board of Trustees of HKCH Charitable Foundation (HKCHCF) for a term of three years with effect from the date of HA Board's approval or until cessation of her membership in the HGC of HKCH, whichever was the earlier; and
  - appointment of Dr Ricky CHAN Wai-keung (b) the (陳偉強醫生), Ms Winnie CHIU Wing-kwan, BBS, JP (邱詠筠女士) and Mr William LO Chi-chung (羅志聰先生), currently HGC Members of HKCH, vice the retirement of Mrs Nina LAM Yuen-bing, Mr Patrick MA Ching-hang Prof Grace TANG and Wai-king, as Trustees of HKCHCF for a term of three years with effect from the date of HA Board's approval or until cessation of their membership in the HGC of HKCH, whichever was the earlier.

9. <u>Members</u> also authorised the Chairman, the Chief Executive and any one Member of the HA Board to fix the seal of HA and authenticate the fixing of the seal for executing the Deed for effecting the approved membership changes.

(Post-meeting note : A declaration was received by the Board Secretary on 8 August 2024 from the Hon Duncan CHIU, pointing out that Ms Winnie CHIU Wing-kwan was his niece and he would like to abstain from the approval of her appointment as a Trustee of HKCHCF. <u>The HA</u> <u>Chairman</u> considered that since the appointment proposal was duly considered and proposed by the HGC of HKCH and the decision by the Board was collective, the declaration received from the Hon Chiu would not cause impact on the proposed appointment approved by the Board.)

## 2023/24 Audited Accounts of Head 708 Subhead 8083MM – One-off Grant to the Hospital Authority for Minor Works Projects Funded under Capital Works Reserve Fund (Restricted AOM Paper No.1968)

10. <u>Members</u> approved the 2023/24 Audited Accounts for Head 708 Subhead 8083MM – One-off Grant to HA for Minor Works Projects Funded under Capital Works Reserve Fund (CWRF) at Annex 1 to the paper.

#### Progress Update and Allocation of Funding for Minor Works Projects under Capital Works Reserve Fund Head 708 Subheads 8083MM/ 8096MM (Restricted AOM Paper No.1969)

(<u>Members</u> noted the progress of minor works projects (capped at \$75 million each) of HA funded under the one-off grant of \$13 billion under the CWRF Head 708 Subhead 8083MM; and approved the proposed allocation of funding for minor works projects in 2024/25 under the remaining fund of Subhead 8083MM and the new grant under Subhead 8096MM. The detailed deliberations were separately recorded in paragraphs 11 to 13.)

#### Proposed Mechanism for Recommending Experienced Non-locally Trained Doctors to Receive a More Attractive Employment Package in the Hospital Authority (Restricted AOM Paper No.1970)

(The subject was discussed and <u>Members</u> approved the proposal of setting up a Special Panel to assess and consider offering a more attractive employment package for non-locally trained doctors possessing niche talents for supporting service development in HA, who are unlikely to attain qualification as Fellow of the Hong Kong Academy of Medicine (FHKAM) or be considered as FHKAM-equivalent, and the proposed recommendation mechanism. The detailed deliberations were separately recorded in paragraphs 14 to 22.)

# Progress Update on Engagement of Additional Service Providers for Hospital Authority Mandatory Provident Fund Scheme (Confidential AOM Paper No.1971)

(<u>Members</u> noted the progress update on the engagement of additional service providers for the HA Mandatory Provident Fund Scheme and supported the proposed tendering arrangements. The detailed deliberations were separately recorded in paragraphs 23 to 26.)
