

一直以來，政府對醫院管理局(醫管局)服務提供高度資助。為確保精準投放資源，減少浪費，由2026年1月1日開始，醫管局於非緊急放射科服務引入共付收費模式，精準善用有限資源，幫助更多緊急及有需要的病人。

收費適用於由門診或急症室安排覆診，以及日間或住院病人出院後的非緊急放射科服務。住院和急症室病人的緊急放射科服務維持免費。

The Government has been highly subsidising the services provided by the Hospital Authority (HA) all along. To ensure medical resources can be precisely allocated to patients needed and reduce wastage, starting from 1 January 2026, the HA introduces co-payment models for non-urgent radiology services. This measure helps precisely allocate limited medical resources to more patients in need of urgent medical service.

The charges apply to non-urgent radiology services arranged through out-patient clinics, Accident & Emergency (A&E) follow-up appointments, day inpatient service, or upon discharge from inpatient care. Urgent radiology services for inpatients and A&E patients remain free of charge.

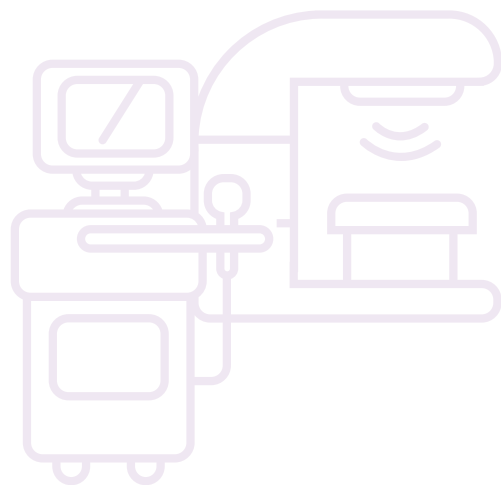


常見問題 ??? Frequently Asked Questions

1 若我在預約日期前14曆日仍未清繳款項，預約將會如何處理？
What will happen if I have not paid at least 14 calendar days before the appointment date?

如病人未能在預約日期前最少14曆日清繳款項，系統將自動取消預約，放射科部門會將預約時段分配給其他病人。若病人需要重新預約，應先由相關醫生根據臨床情況評估是否需要重新將病人轉介放射科服務，放射科部門將進行新的預約排期。

If the patient does not settle the payment at least 14 calendar days before the appointment date, the appointment will be automatically cancelled. The appointment slot will be allocated to another patient by the radiology department. If the patient would like to reschedule the appointment, the related clinician will assess the clinical condition to determine whether a new referral for radiology services is required. The radiology department will arrange a new appointment schedule.



2 我於同一間醫院兩個不同專科覆診，而兩個專科的醫生分別安排我於一個月內接受兩次不同部位的電腦掃描造影服務。是否可以將兩次電腦掃描造影於同一日內進行，而我只需繳付一次費用？

I have two different specialist out-patient clinic appointments arranged under the same hospital, and the specialists have arranged for me two separate CT scans for different body parts in the same month. Can the two CT scans take place within the same day while I only need to pay once?

各項檢查能否於同一日內進行，須視乎放射科部門的實際運作安排而定。非緊急放射科服務按每個項目逐項收費，因此即使能在同一時段接受服務，仍需分別繳付兩次費用。

It depends on the actual operational arrangements of the radiology department whether multiple examinations can be performed on the same day. Non-urgent radiology services are charged per item; therefore, even if the services can be provided during the same time slot, you will still need to make payment by two separate bills.

3 專科門診醫生安排我接受磁力共振掃描造影，我已繳費而預約日期亦已確實。由於病情有變，我到急症室求診，急症室安排我接受同部位的磁力共振掃描造影，我會否獲得安排退款？

A specialist out-patient clinic doctor had arranged an MRI scan for me, and I already paid for it with the appointment date confirmed. Due to a change in my clinical condition, I visited the A&E department where an equivalent MRI scan was carried out. Am I eligible for a refund?

若病人因病情變化，經醫生評估後認為毋須進行原先安排的掃描造影，則可被安排取消原有預約並獲得退款。實際安排由臨床或放射科醫生按個別情況決定。

If the doctor assesses that the originally scheduled imaging scan is no longer necessary due to a change in the patient's condition, the original appointment may be cancelled with a refund. The actual arrangements will be determined by the clinical doctor or radiologist based on the individual circumstances.

預繳費用
Full Pre-Payment

- 病人須於**預約日期前最少14曆日**透過醫管局現有繳費途徑 (例如: HA Go流動應用程式、一站式電子服務站或醫院繳費處)繳費。如病人並非透過以上付款方式 (例如: 7-11便利店)繳費，由於款項過戶需時，須預留最少三個工作天以便處理款項過戶。若以郵寄支票繳費，須預留足夠郵遞及款項過戶時間。
Patients must settle the payment **at least 14 calendar days** before the appointment date through the HA's existing payment methods (e.g., HA Go mobile application, One-stop Electronic Kiosk or hospital shroff). Other than the above payment methods (e.g., 7-Eleven convenience store), at least three working days should be allowed for payment processing. If payment is made by cheque by post, sufficient time should be allowed for mailing and payment processing.
- 如未能在預約日期前最少14曆日清繳全部款項，預約時段將會自動取消並分配給其他病人。
If the payment is not fully settled at least 14 calendar days in advance, the appointment will be automatically cancelled and the slot will be allocated to another patient.
- 如果病人被安排於預約期前少於14曆日內接受服務，病人必須在接受服務前完成繳費。放射科部門將於確認預約日期前以電話聯絡病人，以確定是否能夠出席，不論是否已付款，該預約不會被自動取消。
If the appointment is arranged in less than 14 calendar days, patients must settle the payment before receiving the service. The radiology department will contact the patient by phone to confirm the appointment. Regardless of the payment status, the appointment will not be automatically cancelled.



取消或延期預約
Cancellation or Deferral of Appointments

病人可於**預約日期前最少14曆日取消預約**，以獲得全額退款。

如欲申請取消或延期預約 (最多可申請兩次)，請於預約日期前最少14曆日透過HA Go、郵遞、傳真、親身或授權他人到放射科部門辦理相關手續提出申請 (不接受電話申請)。

Patients can request cancellation for a full refund **at least 14 calendar days** before the appointment date.

For cancellation or deferral (twice at most) of appointment, request can be submitted via HA Go, by mail, by fax, in person, or by authorizing a representative to visit the radiology department for arrangement on your behalf. (Applications by telephone are not accepted).



退款安排
Refund Arrangement

- 如病人選擇於私營醫療機構接受服務，**必須於預約日期前最少14曆日取消預約**。
Patients who choose to receive radiology imaging services at private healthcare institutions must request cancellation **at least 14 calendar days before the appointment date**.
- 在以下情況下病人可獲安排退款：
Refund will be arranged under the following situations:
 - 由於病人情況改變，醫生判斷病人毋須接受有關服務。
Patient's condition changes and the clinician determines that the radiology imaging service is no longer needed.
 - 放射科醫生判斷病人不適合接受服務。
The Radiologist determines that the patient is not suitable to receive the service.
 - 病人於預約當日被判斷為不適合接受相關放射服務 (例如進行磁力共振掃描造影檢查時發現病人患有幽閉恐懼症)。
Patient is deemed unsuitable to receive the service on the day of the appointment (e.g., claustrophobia is identified during an MRI exam).
 - 病人於預約當日身體不適，並提供有效醫療證明書。
The patient is unwell on the day of appointment with a valid medical certificate.
 - 因特殊天氣狀況 (例如八號風球或黑色暴雨警告信號)，放射科部門將自動為病人預約延期。另外，病人亦可選擇全額退款。
Under special weather conditions (e.g., typhoon signal no. 8 or black rainstorm warning), radiology department will automatically postpone the appointments. Patient may also choose to receive a full refund.



醫療費用減免
Medical Fee Waiver

病人如有經濟困難，可申請醫療費用減免。
Patients with financial difficulties can apply for a medical fee waiver.
