Pursuant to the conditions stated in the Public Subscription Permit issued by the Social Welfare Department of the Government of the Hong Kong Special Administrative Region ("SWD"), we have been requested to report on the attached income and expenditure account of the Permittee's general charitable fund-raising activities held for the period from 25 September 2019 to 24 September 2020 ("the Event").

Responsibilities of the Hospital Management

Our engagement included carrying out limited procedures for obtaining sufficient appropriate evidence to be able to draw a conclusion, such as inquiries primarily of persons responsible for financial and accounting matters and other procedures we considered necessary. The procedures performed in a limited assurance engagement vary in nature and timing from, and are less in extent than for, a reasonable assurance engagement. Consequently, the level of assurance obtained in a limited assurance engagement is substantially lower than the assurance that would have been obtained had a reasonable assurance engagement been performed.

Inherent Limitations

Due to the nature of cash receipts and expenses relating to the Event, it was not practicable for us to determine whether the income and expenditure account and the books and records of the Permittee include all transactions relating to the Event. It was impracticable for us to quantify the potential impact of this on the income and expenditure account. Accordingly, our report relates solely to the income and expenditure account prepared from transactions that have been recorded in the Permittee's books and records.

Conclusion

Based on the foregoing, we report that nothing has come to our attention that causes us to believe that the attached income and expenditure account does not reflect, in all material respects, the gross subscriptions raised and the expenses incurred by the Permittee in respect of the Event that have been recorded in its books and records made available to us in accordance with the basis of preparation set out in notes to the account.

Intended Users and Purpose

This report is intended solely for the purpose of assisting the Permittee to satisfy the conditions stated in the Public Subscription Permit issued by SWD in connection with the Event and is not intended to be, and should not be, used for any other purpose. 1. PURPOSE OF THE FUND-RAISING ACTIVITIES EVENT

The purpose of the fund-raising activities event is for -

- (a) To raise funds for patient's benefit; and
- (b) Enhancement of hospital services

2. SIGNIFICANT ACCOUNTING POLICY

The account has been prepared under historical cost convention and on accrual basis.

The significant accounting policy by the company is arriving at the financial information set out in this report is as follow:-

Recognition of income

Revenue is recognized when the amount can be measured reliably and when it is probable that the economic benefits associated with the transaction will flow to the company.

Income from donation boxes in stationed counters are recognized upon the amounts are properly received.

3. TAXATION

The Hospital is a charitable organization which is exempted from tax under Section 88 of Inland Revenue Ordinance.

4. DONATIONS CREDITED TO THE BANK

All the proceeds from donation boxes collected of HK\$10,305.60 have been credited to the designated bank account of the Permittee before being used for payment of expenditure for the purpose(s) specified in the permit by 24 September 2020, if any.
